



### General Club Rules

1. The Club's facilities shall be open on the days and during the hours as may be established from time to time by the Club as they appear in the monthly newsletter. Areas of the Club and Golf Course may be closed from time to time for scheduled maintenance and repairs.
2. Members and their guests are expected to act in a courteous and orderly fashion at all times. Members conducting themselves in a manner deemed inappropriate by management will be asked to leave the club facilities. Suspension and/or termination of membership privileges may result from such behavior.
3. No performance by entertainers will be permitted on the Club facilities without the permission of the General Manager.
4. Commercial or political advertisements shall not be posted or circulated in the Club nor shall solicitations of any kind be made on the Club facilities or upon the Club's stationery.
5. Other than, as permitted by the General Manager, no petition shall be originated, solicited, circulated or posted on any of the Club facilities.
6. Members should not request personal services from employees of the Club who are on duty or the personal use of the Club's furnishings or equipment, which are not ordinarily available for Member's use.
7. Dogs or other pets (with the exception of Assistance Dogs) are not permitted on the Club facilities.
8. Members and their guests may not abuse or harass any of the Club's employees, verbally or otherwise. All service employees of the Club are under the supervision of the General Manager and no Member or guest shall reprimand or discipline any employee, nor shall a Member request an employee to leave the Club facilities for any purpose whatsoever. Any employee not rendering courteous and

prompt service should be reported to the General Manager or Manager on Duty immediately.

9. Smoking is not permitted inside the Clubhouse, the pool complex, sports facility, children's playground, or tennis courts.
10. Firearms and weapons of any kind are not permitted on the Club facilities at any time.
11. Parking is restricted to lined areas in the parking lot. Members are asked to not park in the circular drive in front of the Clubhouse.
12. The Golf Course grounds, which include the Golf Course greens, tees, fairways roughs, driving range, cart paths, sand traps, waste bunkers, lakes and streams, are for the exclusive golfing or maintenance use by Members, guests or employees of the Four Bridges Country Club. Fishing, hunting, jogging, walking, bike riding, dog walking, skateboarding, swimming, boating or other non-golf activities are not be permitted.
13. The Club will not be responsible for articles left at any of the Club's facilities. The Club will maintain a "Lost and Found Department" in the receptionist's office at the main Clubhouse and in the Sports Facility Director's office at the Sports Complex. Items will be kept for sixty (60) days, after which they will be donated to charity.
14. Bath towels should not be taken from the locker rooms, and golf towels supplied with golf carts should remain with the golf carts.
15. The personnel of the Club have full authority to enforce the rules and regulations of the Club. Infractions will be reported to the General Manager.
16. Four Bridges Country Club reserves the right to amend or modify these rules and regulations as it determines appropriate from time to time and will notify the membership of any change.
