



Guest Privileges

Guest privileges may be extended to guests of Members subject to applicable guest fees, charges and rules and regulations established by the Club and amended from time to time. Although it is the intention of the Club to accommodate guests without inconvenience to the Members, the Club reserves the right to limit the number of guests that accompany a Member on any given day. Guest privileges may be denied, withdrawn or revoked at any time for reasons considered sufficient by the Club in its sole and absolute discretion.

Golf Guests

1. An individual may play the course as a guest of a Member six times per season at Four Bridges Country Club. Guest play will be monitored by the golf shop. A letter will be sent by the Golf Professional once a person has reached his or her limit.
2. Guests must be accompanied at all times by the Member during his or her use of the golf course, unless otherwise determined by the Club from time to time.

Note: Initially, Individual, Family and Corporate Golf Members may sponsor unaccompanied guests during certain non-restricted times, which will not interfere with the Member's priority access to the Golf Course. This privilege may be revoked without notice as the volume of play increases.

3. Prior to play the Member must register themselves & their guests in the pro shop. The Member is responsible for any guest fees or charges incurred by their guests.
4. Members are responsible for informing their guests of dress codes and the Club's soft spike requirement.
5. The Member is responsible for the conduct, manner, actions and deportment of their guests while the guests are on Club property.
6. Guests may use the Golf Practice Facilities, including the putting green, driving

range and chipping green immediately before a Member sponsored starting time on the day of play.

7. Non-Members may take golf lessons from the Club's golf professionals. However, priority access to lessons will always remain with the Members.
8. Corporate Golf Members with guests may be subject to limited tee times on weekends and holidays in order to insure Member's priority access to the Golf Course.
9. Based on play volume and tee time availability Member's houseguests may be granted additional golf visitations – such requests should be directed to the Golf Professional.

Sports Complex Guests

1. Social, Athletic/Clubhouse, Racquet Sports, Sports, Individual Golf, Family Golf, and Corporate Golf Members may bring guests to enjoy the various recreational facilities of the Sports Complex, which include the tennis courts, swimming pools, and fitness center. Please note that use of the platform tennis courts is reserved for Athletic, Sports and Full golfing members only. The Member will be responsible for the payment of any guest fees or participation fees for these activity centers.
2. An individual may come as a guest to the Sports Complex at Four Bridges Country Club only six times per calendar year. Houseguests or au pairs may be granted additional visitations pending approval by the Club Manager.
3. The Member is required to register his or her guest(s) at the appropriate registration control point prior to using the facilities.
4. The Member is responsible for advising their guest(s) of appropriate dress codes and the rules and regulations governing the sports facility. Violations of club policies may result in the Member and their guest(s) being asked by the Club to leave the Sports Complex.
5. Except in the case of houseguests or au pairs, Members are required to

accompany their guests when using the Sports Complex.

6. Currently, guest fees will be charged for swimming, tennis, fitness and pool guests.

Clubhouse Guests

1. All Members in good standing are offered the privilege of bringing guests to enjoy the dining and meeting facilities of the Clubhouse.
2. All Members are responsible for advising their guest(s) of appropriate dress codes and the rules and regulations governing the Clubhouse. Violations of Club policies may result in the Member and their guest(s) being asked by the Club to leave the property.
